# TRUSTEE'S PRELIMINARY REPORT

## SECTION A - Background

2646590 Ontario Inc. (the "Company") operated a Fionn MacCool's franchised restaurant from leased premises in Guelph, Ontario. Sean Mangan was the sole director.
The Company fell behind on rent during the lockdowns brought on by the COVID-19 pandemic. In 2023 it was attempting to negotiate settlement of the rent arrears. At the same time the brand was sold to a new franchisor. Unfortunately, neither the Company, nor the new franchisor was successful in their negotiations. In fact, the landlord increased the rent from $\$ 27,000$ to $\$ 41,000$ per month. The Company also fell behind on HST and Source Deductions owing to CRA, accumulating arrears of approximately $\$ 200,000$.
The Company could not generate sufficient sales to justify the increased rent amount so in June 2023 made the decision to shut down.
The Company made an assignment in bankruptcy on April $17^{\text {th }}, 2024$. MNP Ltd. was appointed as Trustee (the "Trustee").

CLASS I - Stocks of merchandise
There was no inventory owned by the Company.
CLASS II - Plant, machinery, equipment, and office
There was no equipment owned by the Company.
CLASS III - Buildings and real estate
The Company did not own real estate.
CLASS IV - Books and records
The Trustee has received the books and records required to administer the bankruptcy.

There are no other assets the Trustee is aware of.
