**AFFIDAVIT OF CLARENCE PERPELUK**


**I Clarence Perpeluk of Wroxton, Saskatchewan make oath and say:**

1. I am a respondent in this matter and as such have personal knowledge of the facts and matters herein stated and where any so information is stated to be on belief, I verily believe same to be true.
2. I am a farmer and for the 2018 crop year I required additional storage of grain.
3. I was aware that Tyson Becker operated a grain storage facility in the Wroxton area and therefore approached him about storing grain at his facility.
4. Tyson advised he could provide grain storage services and provided me an invoice dated December 14, 2018 and requested payment of the invoice amount. The invoice was payable to 102016217 Saskatchewan Ltd. (the "Numbered Co.") I confirmed with Tyson to whom the cheque should be payable and Tyson directed that payment be made to the Numbered Co.
5. In February of 2019, Tyson Becker advised me that my Canola that was stored was starting to heat and Tyson advised that he could move the grain to different bins and provide cooling options. I agreed to such services and was rendered an invoice by Numbered Co. which I paid in full by cheque.
6. The referenced invoices and canceled cheques are attached to the Receiver's Report as Exhibit "H".
7. The storage services referred to above are the only instances that I have utilized storage services from Tyson Becker or any corporation of which he is principal.
8. When I made payment to Numbered Co. I was of the full understanding that I was paying for the above grain storage services in full and at no time prior to making payment in full, did I

ever believe that I should be making payment to anyone other than the Numbered Co.

9. I make this Affidavit in support of an order of this Court declaring that the applicant Receiver does not have a valid and subsisting commercial lien or other interest in the funds held in trust by my lawyer, Shawn Patenaude Law and a further order that the said funds may be paid to me absolutely.
