AFFIDAVIT OF CORTNEY SOLONENKO

I Cortney Solonenko of Stornoway, Saskatchewan make oath and say:

- 1. I am a director and shareholder of the respondent, S & D Solonenko Farms Ltd. ("Solonenko Farms") in this matter and as such have personal knowledge of the facts and matters herein stated and where any so information is stated to be on belief, I verily believe same to be true.
- 2. For the 2018 crop year Solonenko Farms required additional storage of grain.
- **3.** I was aware that Tyson Becker operated a grain storage facility in the Wroxton area and therefore approached him about storing grain at his facility.
- 4. Tyson advised he could provide grain storage services and provided me an invoice dated August 28, 2018 and requested payment of the invoice amount. The invoice was payable to 102016217 Saskatchewan Ltd. (the "Numbered Co.") I confirmed with Tyson to whom the cheque should be payable and Tyson directed that payment be made to the Numbered Co.
- 5. I was aware that Tyson had dealings involving the business name "Beckerland Farms" because the logo was on trucks and I had heard references of Beckerland Farms being a business name associated with Tyson. When it was requested that the cheque be payable to Numbered Co., I did not question the request because I believed that either Beckerland Farms was a separate business from the grain storage or that Numbered Co. carried on business using the business name "Beckerland Farms". All I knew was that Tyson Becker was the principal of the business in any event and that I would take his direction as to whom the cheque would be payable.
- **6.** The referenced invoice and canceled cheque are attached to the Receiver's Report as Exhibit "F".

- 7. The storage services referred to above are the only instances that Solonenko Farms utilized storage services from Tyson Becker or any corporation of which he is principal.
- 8. When I made payment on behalf of Solonenko Farms to Numbered Co. I was of the full understanding that I was paying for the above grain storage services in full and at no time prior to making payment in full, did I ever believe that Solonenko Farms should be making payment to anyone other than the Numbered Co.
- 9. I make this Affidavit in support of an order of this Court declaring that the applicant Receiver does not have a valid and subsisting commercial lien or other interest in the funds held in trust by Solonenko Farms' lawyer, Shawn Patenaude Law and a further order that the said funds may be paid to Solonenko Farms absolutely.
