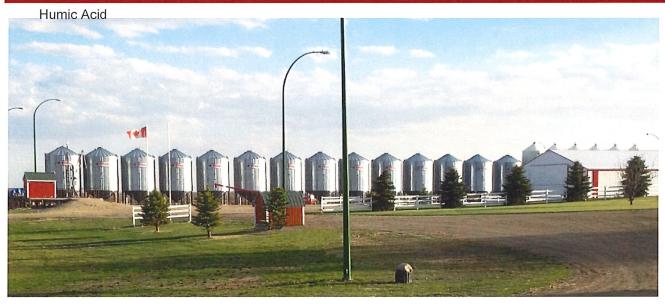

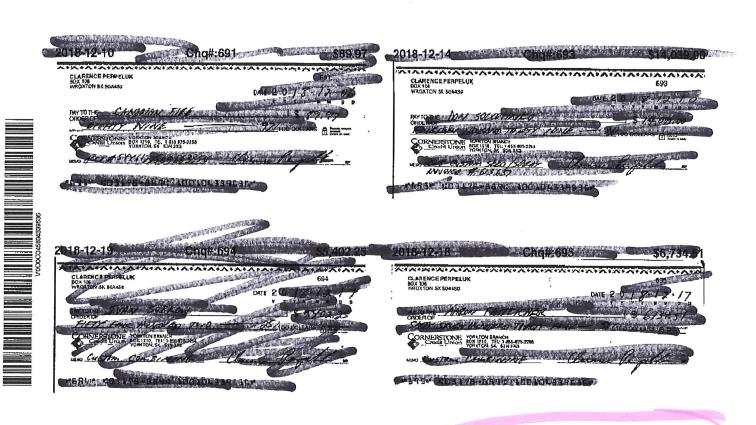

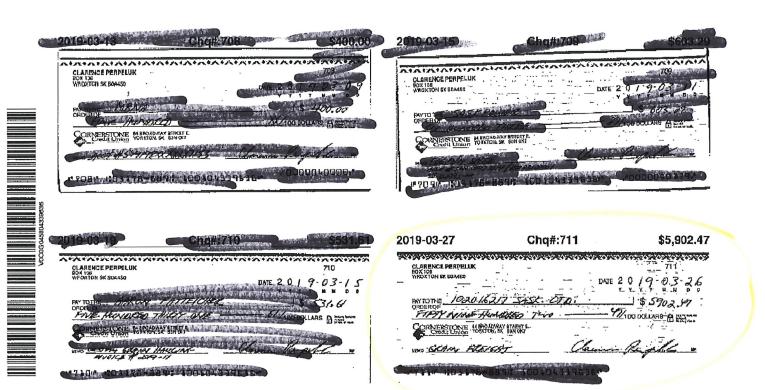

Re: Beckerland Farms, Inc. – in Receivership ("Beckerland Farms")

As you are aware, MNP Ltd. was appointed Receiver of Beckerland Farms Inc. by the Court of Queen's Bench of Saskatchewan, on July 11, 2019. We are writing to you regarding agreements that have been provided to the Receiver by you and by Mr. Cortney Solonenko and Mr. Clarence Perpeluk.

Those agreements, reference grain storage and turning services that were conducted using the assets of Beckerland Farms. As you have advised, there is no agreement between 102016217 Saskatchewan Ltd. and Beckerland Farms for the use of the Beckerland Farms assets, and since the assets providing those services to Mr. Solonenko and Mr. Perpeluk are Beckerland Farm assets, the Receiver requires the payment for those agreements to be made to the Receiver immediately.

We are currently aware of 3 contracts in total where the contracted grain is on the Beckerland Farms property.
