INTRODUCTION AND BACKGROUND


1. On July 5th, 2019, pursuant to a Court Order, MNP Ltd. was appointed Interim Receiver (the “Interim Receiver”), without security, of all of the assets, undertakings and properties of Beckerland Farms Inc. (“Beckerland Farms” or the “Debtor”) acquired for, or used in relation to the business carried on by the Debtor, including all proceeds thereof (the “Interim Receivership Appointment Order”).
2. On July 5, 2019, a representative of the Interim Receiver attended the Debtor’s two Saskatchewan premises; one in Canora and the other in Wroxton. At the property located at the Wroxton Lands (as defined in the Affidavit of Jennifer Koh, sworn June 27th, 2019), an individual was attempting to load grain from a grain bin owned by the Debtor.
3. The individual was advised of the Interim Receivership Appointment Order. In speaking with the farmer who had contracted with the individual to remove the grain, Courtney Solonenko of S&D Solonenko Farms Ltd. (“S&D Solonenko Farms”), the Interim Receiver was advised that S&D Solonenko Farms held a contract for grain storage until July 2019. The Interim Receiver requested all documentary support for the contract in question. Mr. Solonenko provided the Interim Receiver with a contract dated August 28, 2018 in the amount of \$126,000 (inclusive of GST) (the “Grain Storage Contract”). The Grain Storage contract listed 102016217 Saskatchewan Ltd (“102016217”) and not Beckerland Farms as the provider of storage services and facilities.
4. Attached as **Exhibit “A”** is a copy of the Grain Storage Contract, together with a copy of a \$126,000 cancelled cheque payable to 102016217 provided to the Interim Receiver by S&D Solonenko Farms Ltd. pertaining to payment of the amount due for the Grain Storage Contract.
5. Attached as **Exhibit “B”** is a July 8, 2019 Saskatchewan Corporate Registry Profile Report for 102016217 that indicates that 102016217 was incorporated on March 1, 2017 with the registered office as the law firm of Rusnak Balacko Kachur Rusnak. Mr. Tyson Becker, the principal of Beckerland Farms, is listed as 102016217’s sole Director, Officer and Shareholder.

6. The Interim Receiver is continuing to act in accordance with the Interim Receivership Appointment Order.



