1. Ronsons Shoe Stores Ltd. has at some time during the six months immediately preceding the filing of this Application carried on business within the jurisdiction of this Court.
2. Ronsons Shoe Stores Ltd. is justly and truly indebted to The Toronto-Dominion Bank in the approximate amount of \$500,000 (the "**Indebtedness**").
3. The Toronto-Dominion Bank holds security for the payment of the Indebtedness but it is estimated that the value of such security is \$nil.
4. Ronsons Shoe Stores Ltd., within the six months immediately preceding the date of filing this Application has committed the following acts of bankruptcy:
 - (a) ceased to meet its liabilities generally as they became due;

- (b) given notice to its creditors that it has suspended payment of its debts; and
 - (c) permitted execution under which property was seized.
5. MNP Ltd. is a person qualified to act as trustee of the property of Ronsons Shoe Stores Ltd. and has agreed to act as such and is acceptable to the Applicant.

THIS COURT ORDERS that:

1. The Court hereby orders that Ronsons Shoe Stores Ltd., of 300-10991 Shellbridge Way, Richmond, B.C., be adjudged bankrupt by virtue of the Bankruptcy Order hereby made on this date.

2. The Court further orders that MNP Ltd., of 1600-1021 West Hastings Street, Vancouver, B.C., be appointed as trustee of the estate of the bankrupt.
3. The Court further orders that the trustee give security in cash or by bond or suretyship without delay, in accordance with subsection s. 16(1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3 (the “**Act**”); and
4. The Court further orders that the costs of and incidental to this proceeding of The Toronto-Dominion Bank be taxed and paid as between solicitor and client and be paid out of the estate of the bankrupt pursuant to s. 197(2) of the Act.
