2. MNP Ltd. of Suite 2200 – 1021 West Hastings Street, MNP Tower, Vancouver, British Columbia, V6E 0C3, be and is hereby appointed trustee of the bankrupt estate of Westridge;
3. The said trustee give security in cash or by bond or suretyship without delay, in accordance with subsections 16(1) of the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3; and
4. The costs of and incidental to this application are to be paid to BNS out of the assets of the bankrupt estate upon taxation thereof.
