(Pursuant to Section 39 of the Bankruptcy and Insolvency Act)







("Westridge") and on February 4, 2021, the Court granted an Order adjudging Westridge bankrupt, and appointing MNP Ltd. as Licensed Insolvency Trustee ("Trustee") of the bankrupt Estate.
2. The costs of administering the bankruptcy were paid by Scotiabank.
3. Canada Revenue Agency's ("CRA") deemed trust claim is valued at \$531,947.10.
4. The receipts from the collections of accounts receivable, cash in bank, miscellaneous refunds and a pre-bankruptcy GST refund was paid to CRA for its deemed trust claim.
5. Upon its appointment, the Trustee took possession of Westridge's real property. Business Development Bank of Canada has a registered security interest in the real property and decided to realize on its security through foreclosure proceedings. It was determined that the proceeds from the sale of the real property would not be for the benefit of the general body of creditors and the Trustee disclaimed its interest in the real property.
6. A Final Statement of Receipts and Disbursements was approved by the Inspectors and filed with the Office of the Superintendent of Bankruptcy on October 28, 2021. Subsequent to filing the Final Statement of Receipts and Disbursements, an unexpected receipt of \$5,000.00 was received by the Trustee for a security deposit. 
