(the "Monitor") and upon hearing from counsel present on behalf of any other interested parties, and upon reading the Notice of Application, dated January 26, 2022, all filed:

The Court Orders that:

- Time for service of the Application Materials upon all parties listed on the Service List established in these proceedings (a current copy of which is appended as Schedule "A" hereto) is hereby abridged and shall be and is hereby deemed to be good, timely and sufficient.
- 2. Subject to paragraph 3 herein, the Initial Order of the Honourable Mr. Justice Meschishnick granted on August 13, 2021, as extended and amended by the Order dated November 24, 2021 (the "Initial Order") in these proceedings, and the stay of proceedings provided for therein, shall be and are hereby further extended until such time as to be agreed upon by counsel, in coordination with the hearing date referred to herein, such extension date to not be later than February 18, 2022 at 11:59 PM.

- 3. To the extent required pursuant to paragraphs 14, 15 and 16 of the Initial Order, the Stay Period is lifted, and the Applicants have leave to commence a Proceeding, as defined in the Initial Order, for the limited purposes of:
 - (a) Serving Notice of Intention on the company pursuant to section 244 of the *Bankruptcy* and *Insolvency Act*, RSC 1985, c B-3; and
 - (b) Issuing and serving an Originating Application seeking relief including, but not limited to, the appointment of a Receiver over Abbey Resource Corp.
- 4. This matter and the Originating Application, as described in paragraph 3 herein, are to be heard at such a date and time as to be fixed by the Local Registrar and counsel.
