- 1. I am the Municipal Treasurer for the Corporation of Norfolk County ("Norfolk County") and, as a result, have knowledge of the matters deposed to.
- 2. I have reviewed the Applicants' Motion Record ("Record"). I provide this Affidavit for the specific purpose of informing this Honourable Court of the current status of the indebtedness of Clearbeach Resources Inc. ("Clearbeach") to Norfolk County and to assist the Court in its assessment of the proposal and whether it is fair, reasonable and appropriate in the circumstances.
- 3. In my capacity as Municipal Treasurer for Norfolk County, I have access to all municipal records, including records relating to property assessment and municipal taxes, and rely upon those documents for the purposes of this affidavit.
- 4. Norfolk County is a respondent to the Applicants' Motion Record and was a named Creditor in the Notice of Intention to Make a Proposal of Clearbeach Resources Inc. ("NOI"), dated July 29, 2020. The NOI is referenced in the June 21, 2021, Affidavit of Jane Lowrie as being filed July 22, 2020. However, our copy of the NOI is dated July 29, 2020. The County received the NOI on August 4, 2020.
- Attached and marked as Exhibit "A" to this my Affidavit is a true copy of the NOI Norfolk County received. At page six of eight of the NOI, Norfolk County is identified as a creditor owed \$546,527.56.
- 6. The motion record of the Applicants lists the following tax roll number as included within the definition of "Excluded Liabilities": 331054501035210. This tax roll number is reflected in Norfolk County's records as 545-010-35210-0000. I am advised by Sue Boughner (the Manager, Corporate Customer Care and Revenue)

Services), and do verily believe, that 3310 is prefix that denotes Norfolk County.

- 7. Based upon municipal records for this tax roll, as of June 24, 2021, Norfolk County is owed \$678,493.25. Attached and marked as Exhibit "B" to this my Affidavit is a true copy of the Tax Reminder Notice for this roll number.
- 8. This municipal record shows that the account holder for this tax roll number is Tribute Resources Inc. While our records indicate that Tribute Resources Inc. is the account holder. I am advised by the County Solicitor, Paula Boutis, and do verily believe that in July of 2017, ON-Energy Corp. acquired the oil and gas assets of Tribute Resources Inc. and assumed the tax liabilities associated with these upon closing. I am further advised by the County Solicitor, and do verily believe, that ON-Energy Corp. was later amalgamated with Clearbeach.
- 9. Based upon municipal records for this tax roll, the last payment received and applied to Property Tax Roll Number 3310.545.010.35210 is \$222,327.59 posted October 27, 2014. Property tax records do not indicate the name of the person or entity that paid. Attached and marked as Exhibit "C" to this my Affidavit is a true copy of the last record of payment made.
- 10. It is further noted that a corporation known to be affiliated with Clearbeach, specifically Lagasco Inc., is also indebted to Norfolk County for unpaid property taxes in the further amounts of \$403,012.18, as of June 24, 2021. Attached and marked as Exhibit "D" is an accounting of taxes owed by Lagasco Inc., prepared by Sue Boughner.
- 11. Based upon the foregoing statements, the total indebtedness of Clearbeach and affiliated corporations is, as of June 24, 2021, \$1,081,505.43.
- 12. Norfolk County is currently reviewing old agreements of predecessor corporations to Clearbeach to determine if there are any agreements in place between the parties, including easement or Road User Agreements.
- 13. I make this affidavit in response to the Applicants' Motion for an Order (Approval and Vesting Order) and for no other or improper purpose.


