

NOTICE OF MOTION

(returnable November 5, 2019)

Del Equipment Inc. ("DEL") will make a motion before Justice Hainey of the Ontario

Superior Court of Justice (Commercial List) (the "Court") on November 5, 2019 at 10:00 a.m.

or as soon thereafter as the motion can be heard at 330 University Avenue, Toronto, Ontario.

PROPOSED METHOD OF HEARING: The motion is to be heard orally.

THE MOTION IS FOR:

- 1. An Order substantially in the form attached at Tab 3 of DEL's Motion Record dated November 1, 2019 (the "**Motion Record**"), *inter alia*:
 - (a) abridging the time for and validating the service of this Notice of Motion and theMotion Record and dispensing with further service thereof;
 - (b) requiring Gin-Cor Industries Inc. ("Gin-Cor") to deliver \$874,107.08 to the Monitor (as defined below) pursuant to Rule 45.02 of the Ontario *Rules of Civil*

Procedure, R.R.O. 1990, Reg. 194 (the "**Rules**") notwithstanding any commingling of the Funds (as defined below) with other funds, or dissipation of the Funds;¹ and

- (c) granting DEL an equitable lien on all of Gin-Cor's current and future assets, undertakings and properties of every nature and kind whatsoever, and wherever situate, including all proceeds thereof until such time as Gin-Cor delivers \$874,107.08 to the Monitor;
- 2. Costs of this motion on a substantial indemnity basis; and
- 3. Such further and other relief as counsel may request and this Court may permit.

THE GROUNDS FOR THE MOTION are as follows:

- 4. DEL is a leading Canadian truck body and equipment "up-fitter" that engineers, designs, manufactures and sells special truck bodies, attachments, equipment and work-ready vehicles.
- 5. On October 22, 2019, DEL sought protection from its creditors under the *Companies' Creditors Arrangement Act* (the "CCAA") and obtained an Order (the "Initial Order") which granted, among other things, a stay of proceedings in respect of DEL and appointed MNP Ltd. as the monitor (the "Monitor") of DEL in the CCAA proceedings.
- 6. Also on October 22, 2019, DEL obtained an Order (the "**First Preservation Order**") which, among other things, required Gin-Cor to transfer funds it received from Mack

Defense, LLC by wire transfer on or about August 28, 2019 and September 5, 2019, being the amount of \$874,107.08 (the "**Funds**"), to the Monitor by no later than October 25, 2019.

- 7. DEL's counsel, Goodmans LLP ("Goodmans"), wrote to Gin-Cor on October 22, 2019 advising Gin-Cor of DEL's commencement of these CCAA proceedings, the issuance of the Initial Order and the issuance of the First Preservation Order, including that Gin-Cor was required pursuant to the First Preservation Order to transfer the Funds to the Monitor by no later than October 25, 2019. Goodmans also advised that it would take steps on behalf of DEL to enforce the First Preservation Order in the event of Gin-Cor's noncompliance.
- 8. Gin-Cor's counsel, Kagan Shastri LLP ("**Kagan Shastri**"), wrote to Goodmans on October 25, 2019, the day on which Gin-Cor was required pursuant to the First Preservation Order to transfer the Funds to the Monitor, advising that all or substantially all of the Funds have been commingled and used by Gin-Cor in the ordinary course of its business, and that Gin-Cor was unable to make payment of the Funds to the Monitor given that the Funds have been depleted.
- 9. Goodmans responded to Kagan Shastri on October 28, 2019, advising that the First Preservation Order required Gin-Cor to deliver a certain sum of money to the Monitor (i.e. \$874,107.08) but does not require Gin-Cor to deliver the exact funds given that cash is fungible and neither Rule 45.02 nor the First Preservation Order are dependent on the Funds not being commingled or traceable.

- Gin-Cor has failed to transfer \$874,107.08 to the Monitor as required pursuant to the First Preservation Order, and is in breach of the First Preservation Order.
- 11. Gin-Cor has not confirmed that it has sufficient funds to comply with the First Preservation Order. Accordingly, the Applicant also seeks an equitable lien on Gin-Cor's current and future assets and properties of every nature and kind (including all proceeds thereof) until such time as \$874,107.08 is paid by Gin-Cor to the Monitor.
- 12. The provisions of the CCAA.
- 13. Rules 1.04, 1.05, 2.03, 3.02, 37, and 45.02 of the Rules.
- 14. Such further and other grounds as counsel may advise and this Honourable Court may permit.



As you know, we are counsel to Del Equipment Inc. ("DEL").

Further to our letter of October 10, 2019, please be advised that on October 22, 2019, DEL commenced proceedings before the Ontario Superior Court of Justice (Commercial List) (the "**Court**") pursuant to the *Companies' Creditors Arrangement Act* (the "**CCAA Proceedings**"). A copy of the Initial Order granted in the CCAA Proceedings as well as DEL's Application Record is enclosed for your reference and hereby served upon you.

Please be further advised that on October 22, 2019, the Court granted a Preservation Order (the "**Preservation Order**") in the CCAA Proceedings, a copy of which is enclosed for your reference and hereby served upon you, together with DEL's related Motion Record.

Pursuant to the Preservation Order, Gin-Cor Industries Inc. ("Gin-Cor") is ordered by the Court to transfer funds in the amount of <u>\$874,107.08</u>, representing the funds received by Gin-Cor from Mack Defense, LLC ("Mack Defense") via wire transfers made on August 28, 2019 and September 5, 2019, to the Court-appointed Monitor, MNP Ltd. (the "Monitor"), forthwith and in any event no later than <u>October 25, 2019</u>. The Monitor will hold such funds on the terms provided for in the Preservation Order.

Accordingly, in accordance with the Preservation Order, this letter is to demand that Gin-Cor forthwith, and by no later than October 25, 2019, transfer funds in the amount of \$874,107.08 to the Monitor via wire transfer of immediately available funds. The Monitor is in the process of establishing an account to hold such funds and we will forward payment details shortly.

Please be advised that if Gin-Cor fails to comply with the Preservation Order, DEL may commence contempt proceedings against Gin-Cor and seek further or other remedies from the Court.

As indicated in DEL's materials filed with the Court, in the event the outstanding payment dispute involving DEL, Gin-Cor and Mack Defense is not resolved to DEL's satisfaction in the near-term, DEL intends to seek an expedited resolution of the dispute before the Court in the CCAA Proceedings. Our next scheduled attendance before the Court is November 14, 2019, at 9:30 am. To that end, to the extent you have engaged counsel, please have them call us as soon as possible to discuss these matters.

DEL reserves all of its rights and remedies with respect to these matters and otherwise in relation to Gin-Cor, including, without limitation, to hold Gin-Cor fully liable for any and all damages that DEL has suffered arising from Gin-Cor's unlawful receipt and holding of the funds paid to it by Mack Defense, and including legal costs incurred by DEL on a full indemnity basis.





We refer to your letter of Friday, October 25, 2019, in which you note that your clients are refusing to pay funds to the Monitor as is required by the Preservation Order granted by Justice Hainey of the Ontario Superior Court of Justice (Commercial List) (the "Court") on Tuesday, October 22, 2019 (the "Preservation Order").

We also note that you delivered your letter at 4:13pm on Friday, despite the fact that your client was to deliver the funds by that point in time. The late delivery of your letter appears to have been done to deprive our client of the opportunity to seek further relief from the Court before the weekend. A letter indicating that your client was going to refuse to comply with the Preservation Order could have, and should have, been delivered much sooner.

In any event, your client has misconstrued the requirements of the Preservation Order. The Preservation Order requires your client to deliver a certain sum of money to the Monitor (i.e. \$74,107.08). It does not require your client to deliver the exact funds that it improperly received from Mack Defense – cash is clearly fungible and neither Rule 45.02 nor the Preservation Order are dependent upon the funds improperly received by your client not being commingled or traceable. See paragraphs 19 and 20 of our Factum and the cases cited therein.

Accordingly, your client is in breach of the Preservation Order.

If the required funds are not delivered to the Monitor by 12:00 pm (noon) (Toronto time) on Tuesday, October 29, 2019, we will take the steps to compel compliance by your client, including seeking a contempt order against it and the officers and directors who are preventing it from complying with the Order.

In the meantime, your client is hereby put on notice that it must immediately (i) segregate, hold separate and not use, transfer, distribute or alter any assets that constitute direct and indirect proceeds of the funds your client received from Mack Defense; (ii) not use, withdraw or transfer any further funds from the accounts into which the funds from Mack Defense were deposited; and (iii) provide notice to all persons who received the "funds" your client received from Mack Defense that they hold such funds upon a constructive trust and cannot further use such funds until further order of the Court.

Furthermore, based on the contents of your letter, it appears that Gin-Cor may not in any event have sufficient funds to comply with the Preservation Order. Unless you provide us with confirmation in writing that Gin-Cor does have funds available to comply with the Preservation Order by 5:00 pm (Toronto time) on Monday, October 28, 2019, we will advise the Court accordingly and seek the appropriate relief.



We refer to our letter to you of October 28, 2019, which was a response to your letter of Friday, October 25, 2019. In our letter, we addressed the fact that your client, Gin-Cor Industries Inc. ("Gin-Cor") was in continuing breach of the Preservation Order granted by Justice Hainey of the Ontario Superior Court of Justice (Commercial List) (the "Court") on Tuesday, October 22, 2019 (the "Preservation Order").

Despite our letter of October 28, 2019, Gin-Cor continues to remain in breach of the Preservation Order, has failed to provide the information that it promised in your letter (the provision of which would not excuse the continuing breach of the Preservation Order), and has not provided the confirmations requested. In our letter, we advised that if the funds were not paid to the Monitor and if we did not receive certain confirmations by earlier this week, we would be forced to take further steps before the Court. Your client has failed to deliver the funds to the Monitor and has failed provide the requested confirmation or otherwise communicate with us.

("**Gin-Cor**") shall deliver \$874,107.08 to MNP Ltd. in its capacity as monitor of the Applicant (the "**Monitor**") forthwith and in any event by no later than 4:00 pm (Toronto time) on November 7, 2019, which funds shall represent the Funds (as defined in the First Preservation Order). For the avoidance of doubt, the \$874,107.08 to be delivered by Gin-Cor to the Monitor pursuant to this paragraph 2 shall be delivered notwithstanding any commingling of the Funds with any other funds, or any dissipation of the Funds.

3. THIS COURT ORDERS that until such time as Gin-Cor delivers \$874,107.08 to the Monitor, the Applicant is hereby granted an equitable lien on all of Gin-Cor's current and future assets, undertakings and properties of every nature and kind whatsoever, and wherever situate, including all proceeds thereof, and the Applicant is hereby authorized to register notice of such equitable lien in the Ontario Personal Property Security Registration system, the Ontario Land Registration system, and any other analogous registration system wherever located.

4. THIS COURT ORDERS that the Monitor shall continue to have the benefit of all the protections as set out in the First Preservation Order and all such protections shall apply and extend to the Monitor in carrying out the provisions of this Order and shall extend to any authorized representatives acting upon the direction of the Monitor.

5. THIS COURT ORDERS that Gin-Cor shall pay the Applicant's costs of this motion in the amount of \$______ within seven (7) days of the date hereof.

GENERAL

6. THIS COURT HEREBY REQUESTS the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada, the United States or any other foreign jurisdiction, to give effect to this Order and to assist the Applicant, the Monitor and their respective agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Applicant and to the Monitor, as an officer of this Court, as may be necessary or

desirable to give effect to this Order, to grant representative status to the Monitor in any foreign proceeding, or to assist the Applicant and the Monitor and their respective agents in carrying out the terms of this Order.
