TO THE CREDITORS OF THE KSF GROUP

TAKE NOTICE that on November 6, 2020, an Order (the "Initial Order") was granted by the Ontario Superior Court of Justice (Commercial List) (the "Court") pursuant to the Companies' Creditors Arrangement Act, R.S.C. 1985, c. C-36, as amended ("CCAA") granting the KSF Group various relief including, but not limited to, the imposition of an initial Stay of Proceedings through to November 16, 2020 (the "Stay Period"). On November 13, 2020, the Court ordered, inter alia, an extension of the Stay Period through February 19, 2021. Pursuant to the Initial Order, MNP Ltd. was appointed as CCAA monitor (in such capacity, the "Monitor").

The Initial Order has been posted on the Monitor's website (the "Monitor's Website"): https://mnpdebt.ca/kingstreetrestaurantgroup. Other relevant information regarding these proceedings, including a list of known creditors, the Monitor's reports, Court orders, and





written communications and notifications from the Monitor, will be made available on the Monitor's Website from time to time. Creditors are encouraged to check the Monitor's Website regularly for updates as to the status of these proceedings.

During the Stay Period, all parties are prohibited from commencing or continuing legal or enforcement actions against the Companies and all rights and remedies of any party against or in respect of the Companies or their assets are stayed and suspended except with the written consent of the appropriate Company or Companies and the Monitor, or leave of the Court.

The KSF Group had been actively developing its reopening strategy (the "Reopening and Expansion Plan") as a result of the announcement by the Ontario Government on November 3, 2020 that in-person dining would be permitted in the Greater Toronto Area as early as November 14, 2020. However, subsequent restrictions imposed by the City of Toronto, announced on November 10, 2020, have prohibited any in-person dining until at least December 12, 2020. As a result, the Reopening and Expansion Plan has been put in abeyance until such time as applicable by-laws are amended to permit in-person dining. The Companies are continuing to explore the possibility of expanding their takeout and delivery offerings. If you have questions with respect to continued operations, please contact the appropriate Company or Companies directly.

At this stage, a claims process has not been put in place. As such, creditors are not, for the time being, required to file proofs of claim. Any claims process will be subject to a future Court order and notice will be provided in accordance with any such future order.
