**APPLICATION FOR COURT APPROVAL OF PROPOSAL PURSUANT TO
THE *BANKRUPTCY AND INSOLVENCY ACT***

Remedy claimed or sought:

1. an Order (the "**Approval Order**") pursuant to sections 58 and 60(5) of the *Bankruptcy and Insolvency Act*, RSC 1985, C B-3, (the "**BIA**"), Rule 10-4(2) of the Queen's Bench Rules and the inherent jurisdiction of this Honourable Court, substantially in the form of the draft Approval Order filed herewith:
 - a. validating service of this Notice of Application and the materials filed herewith;

- b. approving the Amended Proposal to Creditors of 101100090 Saskatchewan Ltd. (the “**Company**”) pursuant to Division I of the BIA;
- c. waiving the requirements of Rule 10-4(2); and
- d. providing such further and other relief that Court may deem appropriate or necessary.

Grounds for making this application:

2. On June 26, 2020, the Applicant, 101100090 SASKATCHEWAN LTD., filed a Notice of Intention to Make a Proposal (the “**NOI**”) pursuant to section 50.4(1) the *BIA* with the Superintendent of Bankruptcy.
3. The Bowra Group Inc. (the “**Proposal Trustee**”) consented to act as Proposal Trustee for the NOI proceedings of the Company.
4. On October 29, 2020, the Proposal Trustee filed an Amended Proposal for the Company (the “**Amended Proposal**”), pursuant to Division I of the BIA.
5. On November 12, 2020, a meeting of creditors was held to vote on the Amended Proposal.
6. The Amended Proposal was passed with the requisite majority required by section 54(2)(d) of the BIA.
7. The requirements of the BIA have been satisfied. Specifically:
 - a. the terms of the Amended Proposal are reasonable;
 - b. the terms of the Amended Proposal are calculated to benefit the general body of creditors of the Company;
 - c. the Amended Proposal is made in good faith; and
 - d. the formalities of the BIA have been complied with and the terms required by the BIA to be included in the Proposal are in the Amended Proposal.
