
AFFIDAVIT OF ANDREW RYGH


I make oath and give evidence as follows:

1. I am Andrew Rygh, Account Manager, of the Special Accounts Management Unit of BMO Bank of Montreal ("**BMO**") which is a Judgment creditor of each of Atlantic Crane & Material Handling Limited, Labrador Cranes 2005 Limited, and LCB Rentals Limited (when referenced collectively below, the "**Debtors**"), which have jointly filed a Notice of Intention to Make a Proposal ("**NOI**").
2. I have personal knowledge of the evidence sworn to in this Affidavit except where otherwise stated to be based on information or belief.
3. I state, in this Affidavit, the source of any information that is not based on my own personal knowledge, and I state my belief of the source.
4. Among the Debtors which have filed the NOI in these proceedings is LCB Rentals Limited. On June 21, 2021 at approximately 1:30 p.m., BMO's counsel forwarded to me materials filed on behalf of the Debtors with this Honourable Court, in respect of Motions scheduled by the Debtors for Thursday June 24, 2021 seeking: (a) an Order extending the stay of proceedings in this matter to and including August 21, 2021; and (b) an Order approving a sale by LCB Rentals Limited ("**LCB**") of certain industrial real property owned by LCB in Saint John, New Brunswick, more particularly described as 20 Grandview Avenue, and identified by Parcel Identification No.36236 (the "**Warehouse**").
5. BMO is a Judgment creditor of the Debtors by virtue of two (2) Judgments issued by the Supreme Court of Nova Scotia on March 4, 2020, in respect of Guarantees given by the Debtors of the indebtedness to BMO of companies by the name of Yarmouth Forklift Limited (an initial Judgment debt of \$1,031,205.87) and B&D

Rentals Limited (an initial Judgment debt of \$222,557.88). True copies of the Judgments BMO holds against the Debtors are attached hereto and collectively marked as Exhibit “A”.

6. On or about December 4, 2020, BMO caused its solicitors in the Province of New Brunswick to obtain recognition of the larger of the two Judgments (then standing at a total of \$1,067,854.47) in New Brunswick, pursuant to the *Canadian Judgments Act* (New Brunswick), which I am advised by counsel and verily believe amounts to the Judgment’s recognition in the Province of New Brunswick as a Judgment of the Court of Queen’s Bench of New Brunswick. A true copy of the Judgment as recognized by the New Brunswick Court is attached hereto and marked as Exhibit “B”.
7. On or about December 16, 2020, BMO’s solicitors recorded the aforementioned Judgment in the Province of New Brunswick against the Warehouse, pursuant to the provisions of the *Enforcement of Money Judgments Act* (New Brunswick) and the *Land Titles Act* (New Brunswick) as Document No. 40805708, and a true copy of a record showing BMO’s *Land Titles Act* recorded interest in the Warehouse is attached hereto and marked as Exhibit “C”.
8. Also on December 16, 2020, BMO’s solicitors registered the Judgment pursuant to the *Personal Property Security Act* (New Brunswick), and a true copy of the record of this registration is attached hereto and marked as Exhibit “D”.
9. On June 18, 2021, I received from BMO’s solicitor a search report pursuant to the *Personal Property Security Act* (New Brunswick), a true copy of which is attached hereto and marked as Exhibit “E”. I am advised by BMO’s solicitors and verily believe that this search report indicates that on June 17, 2021, The Toronto-Dominion Bank registered a financing statement describing a security interest being taken in respect of certain personal property of the Debtors located in the Province of New Brunswick.
