I, LYNNE MOORE, of the City of Toronto, in the Province of Ontario, MAKE OATH AND SAY THAT:

### I. INTRODUCTION

- 1. I am the Mortgage Administrator of Romspen Investment Corporation ("**RIC**"), the manager and administrative agent for Romspen Mortgage Limited Partnership (together with RIC, "**Romspen**"). As such, I have personal knowledge of the matters and facts hereinafter sworn to, except where stated to be based on information and belief, and where so stated, I verily believe the same to be true.
- 2. Capitalized terms not defined herein shall have the same meaning as those terms defined in the Affidavit of Wesley Roitman sworn on July 29, 2022.

#### **II. STATEMENT OF INDEBTEDNESS**


3. The indebtedness owing to Romspen pursuant to the Zen Garden Loan Agreement, the Alberta Security and the Alberta Guarantees is, as of June 30, 2023, USD \$108,825,570.69, with interest continuing to accrue at the rate of 17% per annum, calculated and compounded monthly. Attached hereto and marked as Exhibit "A" is a loan statement dated

effective June 30, 2023, which provides itemized details on the indebtedness calculation (the "Loan Statement").

- As set out in the Loan Statement, Romspen has incurred the amount of USD \$3,685,425.67 4. in payment for outstanding property taxes owing by Eco-Industrial and Lot 11 GP.
- 5. To assist the Court with determining the Canadian Dollar equivalent of the indebtedness owing to Romspen, attached hereto and marked as Exhibit "B" is a copy of a .pdf printout from the Bank of Canada's website of the 6-month historical USD/CAD conversion rates generated and printed on July 6, 2023.
- 6. Based on the Bank of Canada's indicative USD/CAD conversion rate of 1:1.3273 as of July 5, 2023, the amount of indebtedness owing by Romspen as set out in the Loan Agreement, expressed in Canadian Dollars, is CAD \$144,444,179,98, exclusive of incremental daily interest calculation beyond July 5, 2023
- 7. Further, as of June 30, 2023, Romspen has incurred the amount of CAD \$1,891,558.24 in funds advanced to the Receiver in the within receivership proceedings, with interest continuing to accrue at the rate of 12% per annum, calculated and compounded monthly. Attached hereto and marked as Exhibit "C" is a copy of a discharge statement dated effective June 30, 2023 in respect of the Receiver's borrowings from Romspen.

#### III. CONCLUSION

- I make this Affidavit further to the Supplemental Affidavit of Wesley Roitman sworn on 8. August 9, 2022 in these proceedings, in order to provide updated information on the indebtedness owing to Romspen pursuant to the Zen Garden Loan Agreement.
- 9. I am authorized to swear this Affidavit on behalf of Romspen.
