**AFFIDAVIT OF ALEKSANDR GORODETSKY****Sworn on February 17, 2021**

I, **ALEKSANDR GORODETSKY**, of the City of Calgary, in the Province of Alberta, **SWEAR AND SAY THAT:**

1. I am a judgment creditor and former employee of Alter NRG Corp. ("**Alter**") and as such have personal knowledge of the matters hereinafter deposed to, except where stated to be based upon information and belief, and where so stated I verily believe the same to be true.

2. This Affidavit is sworn in support of an application filed by me along with Bruce Leonard and Kenneth Willis (the "**Writ Holders**" or "**Applicants**") in these proceedings for, among other things, the following relief (the "**Application**"):
  - (a) declaring that the time for service of this application be abridged, that this application is properly returnable, and that further service of this application be dispensed with, if necessary;
  - (b) appointing KPMG Inc., as receiver and receiver and manager (the "**Receiver**") of all current and future assets, undertakings and properties of every nature and kind whatsoever, and wherever situate of Alter (the "**Property**") pursuant to sections 85 of the *Civil Enforcement Act*, RSA 2000, c C-15 and section 13(2) of the *Judicature Act*, RSA 2000, c J-2;
  - (c) granting the Receiver the power to enter into a Restructuring Agreement (defined herein) with Refacture Inc. ("**Refacture**");
  - (d) authorizing and approving the termination fee in the Restructuring Agreement (the "**Termination Fee**");
  - (e) granting at charge against the Property in order to protect the Termination Fee (the "**TF Charge**"), to be ranked as a third charge behind the receiver's charge and the receiver's borrowing charge; and
  - (f) granting the Receiver the power to enter into a proposal to creditors pursuant to the *Bankruptcy and Insolvency Act*, RSC 1985 c B-3 (the "**BIA Proposal**") and complete any reorganization permitted by law, if necessary.
3. Alter, is a body corporate pursuant to the laws of the Province of British Columbia and is extra-provincially registered in Alberta. Alter's head office and principal place of business was in the City of Calgary. A copy of the Alberta Corporate Registry Search, dated February 15, 201, for Alter is attached hereto and marked as **Exhibit "A"**. A copy of the British Columbia Corporate Registry Search, dated February 15, 2021, for Alter is attached hereto and marked as **Exhibit "B"**.
4. Alter does not appear to have any secured creditors. Attached hereto and marked as **Exhibit "C"** is a copy of the Alberta Personal Property Security Registry search for Alter dated February 15, 2021. Attached hereto and marked as **Exhibit "D"** is a copy of the British Columbia Personal Property Security Registry search for Alter dated February 15, 2021.

5. In April, 2007, Alter acquired unique intellectual property that enabled it to convert difficult feedstock into useful energy products (the "**Alter Technology**").
6. From April 2007 to November 2008, Alter operated as a publicly traded company listed on the TSX Venture Exchange. On November 17, 2008, Alter graduated to the Toronto Stock Exchange ("**TSX**"), where it remained publicly traded until September 1, 2015 when it was taken private.
7. I understand that Alter has one shareholder, Harvest International New Energy Co. Ltd., ("**Harvest**") which I understand is a corporation existing under the law of the State of Delaware, USA.
8. The Applicants, including myself, held the following executive positions with Alter:
  - (a) Alex Gorodetsky - Vice President Sales Engineering, from July 24, 2015 to March 15, 2019;
  - (b) Bruce Leonard - Vice President Business Development, from July 24, 2015 to March 15, 2019; and
  - (c) Ken Willis – Vice-President Strategic Alliances & Business Development, from July, 2010 to March 15, 2019.
9. Alter was duly served with the Statement of Claim. Alter never disputed the claims that we made and Alter never defended the QB action. As a result, on May 30, 2019, the Applicants obtained judgment against Alter in the total amount of \$1,125,890.00. Attached hereto and marked as **Exhibit "E"** to this my Affidavit is a copy of the Default Judgment.
10. Immediately after the Default Judgment was obtained, a copy of same was served on Alter. Attached hereto and marked as **Exhibit "F"** to this my Affidavit is a copy of a letter dated May 30, 2019 from our counsel to Alter.
11. After obtaining our judgment against Alter, on May 31, 2019 our counsel arranged to have a Writ of Enforcement registered against Alter in the Personal Property Registry. Attached hereto and marked as **Exhibit "G"** to this my Affidavit is a copy of a Personal Property Registry Search Result for Alter, showing registration of our Writ of Enforcement.

***Alter's Current Position***

12. We have made many demands for payment of our judgment, yet we have not been paid anything by Alter towards the judgment.

13. I was informed by Richard Fish, the former President of Alter that he and Danny Hay, the former Chief Financial Officer of Alter were the last employees of Alter and that they both stopped providing services to Alter in January, 2020.
14. I am aware from both the time that I was employed with Alter and since my employment has ended, that Alter has no ability to pay the judgment. I am also aware that there are other creditors of Alter, in particular Alter owes more than \$125,000.00 to its travel agent, Corporate Travel.
15. I verily believe that Alter has committed an act of bankruptcy as Alter is unable to meet its liabilities generally as they become due, including its liability to the Applicants.
16. The only means the Applicants have to realize upon the Judgment is to monetize the Alter Technology as it appears to be the only Alter asset of significance.
17. Given the nature of the Alter Technology, it is not practicable or feasible for the Applicants to monetize the asset without the use of a receiver and manager who can also manage the estate for the benefit of the larger body of creditors and assist with any required reorganization.


***Restructuring Agreement / Termination Fee***

18. The Applicants were introduced to Refacture who is interested in acquiring the Alter Technology and the shares of Alter.
19. The Applicants and Refacture have expended a considerable amount of time, effort and expense in order to structure a process, which will provide near full recovery for the Applicants and other unsecured creditors.
20. I am advised by my counsel, Michael Aasen, at McLennan Ross LLP, that it understands that in order for Refacture to assist the Applicants, it requires the use of a restructuring agreement to be entered into between the Receiver and Refacture (the "**Restructuring Agreement**").
21. The Restructuring Agreement outlines the process by which Refacture will fund a creditor pool, through a BIA Proposal, that can be used to payout the Applicants and other unsecured creditors.
22. I am further advised by Michael Aasen of McLennan Ross LLP that it understands that as part of the Restructuring Agreement, Refacture requires protection of its time and expenses to date by way of the Termination Fee, which is to be secured against the Property.

23. I make this Affidavit in support of the Application for the relief set out in paragraph 2 above.
