**THE RECEIVER GIVES NOTICE AND DECLARES THAT:**

On April 29, 2021, MNP Ltd. was appointed as the Receiver (the “Receiver”) of all of the assets, undertakings and property (the “Property”) of Alter NRG Corp. (“Alter” or the “Company”). pursuant to an Order (the “Order”) pronounced by the Court of Queen’s Bench of Alberta.

**BACKGROUND**

The Company was headquartered in Calgary, Alberta where it provided alternative energy solutions. The Company sold its Westinghouse Plasma Gasification Technology through a wholly owned subsidiary called Westinghouse Plasma Corp. The proprietary plasma gasification technology was used to convert biowaste into renewable energy solutions including liquid fuels, electrical power, and syngas. On March 27, 2015, the Company was acquired by Harvest International New Energy through its wholly owned subsidiary, 1030629 B.C. Ltd.

**ASSETS**

The Receiver is in the process of gathering information related to the property for the purpose of evaluating its next steps with respect to realization. The Property includes the intellectual property and patents related to the plasma gasification technology.

## **CREDITORS**

The Receivership Order was granted pursuant to an application by Aleksandr Gorodetsky, Bruce Leonard and Kenneth Willis (the "Applicants"). The Applicants obtained a judgement against Alter on May 30, 2019 in the total amount of \$1,125,897.00. The judgement was registered as a Writ of Enforcement against Alter in the Personal Property Registry. Alter does not have any secured creditors. A complete list of Alter's creditors is attached as Exhibit "A".

## **PLAN OF ACTION**

The Receiver is determining what assets are owned by Alter and then will determine the appropriate method to realize on these assets. Any such process will be approved by the Court.
