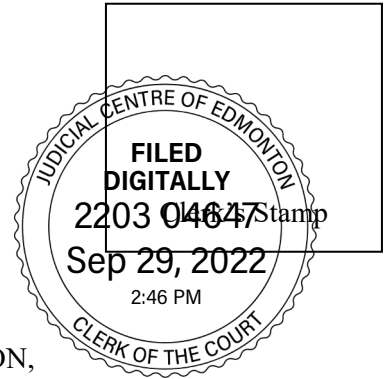

UPON THE APPLICATION by MNP Ltd. in its capacity as the Court-appointed receiver (the “Receiver”) of the undertakings, property and assets of 1692260 Alberta Ltd. and Birkill Holdings Ltd. for an order approving the Receiver’s activities, as more particularly outlined in the Second Report of the Receiver, dated September 26, 2022 (the “**Second Report**”) and the confidential addendum to the Second Report (the “**Confidential Addendum**”); **AND UPON HAVING READ** the Receivership Order granted on March 24, 2022 (the “**Receivership Order**”), the Second Report, the Confidential Addendum to the Second Report, and the Affidavit of Service of Crystal Topilko, sworn September 28, 2022 (the “**Affidavit of Service**”); **AND UPON HEARING** the submissions of counsel for the Receiver, Royal Bank of Canada, and Agriculture Financial Services Corporation, and any other counsel present; **AND UPON** no one appearing for any other person on the service list, although properly served as appears from the Affidavit of Service, filed;

IT IS HEREBY ORDERED AND DECLARED THAT:
