

**NOTICE of ABANDONMENT, DISPOSITION, RELEASE and DIVESTITURE**

**Re: COGI LIMITED PARTNERSHIP, CANADIAN OIL & GAS INTERNATIONAL INC.,  
CONSERVE OIL GROUP INC., AND CONSERVE OIL 1<sup>ST</sup> CORPORATION  
(collectively, "COGI") – IN RECEIVERSHIP**

Pursuant to an Order of the Court of Queen's Bench of Alberta pronounced on October 26, 2015 (the "**Receivership Order**"), MNP Ltd. was appointed as receiver and manager (the "**Receiver**") of the current and future assets, undertakings and properties of COGI. 
In accordance with section 14.06(4)(c) of the *Bankruptcy and Insolvency Act* (Canada) and paragraphs 4(c) and 16(c)(iii) of the Receivership Order, the Receiver hereby abandons, renounces and divests any interest of the Receiver and COGI in the wells, facilities, pipelines and surface leases listed on Schedule "A", and the associated portions of the lands, licenses and leases, (collectively, the "Disclaimed Interests"); and this shall constitute notice to the addressees hereof.

The Receiver has reached this decision after considering:

1. Niven Fischer was retained by the Receiver to operate and manage the oil and gas properties of the entities in receivership. Niven Fischer employees and Contractors have made it clear to the Receiver that they will not work on lands owned or leased from Jack and Melanie Ross as a result of the continual confrontations. The dispute has been detailed in various correspondence sent to the AER from both the Receiver's counsel, and the Ross' agent;
2. The future costs (legal and otherwise) of operating the Disclaimed Interests and dealing with Jack and Melanie Ross in the future, have made the Disclaimed Interests uneconomic.
