UPON the joint application of:

- (a) MNP Ltd. in its capacity as Receiver (the "Receiver") of Intelife LP ("ILP"), Intelife GP Ltd. ("IGP"), Intelife Financial Corporation ("IFC") and Intelife Security and Automation Ltd. ("ISA") (ILP, IGP, IFC and ISA being hereinafter collectively referred to as "Intelife" or the "Debtor"),
- (b) Capitol Security Group Ltd. ("Capitol"), Turniphome Inc. ("Turnip") and Pulse Medical Inc. ("Pulse") (Capitol, Turnip and Pulse being hereinafter collectively referred to as the "Dealers"); and
- (c) Bojan Konstandinovic ("Bojan");

AND UPON noting consent to this Order by counsel for the Receiver, counsel for Bojan and counsel for the Dealers;

AND UPON noting that:

- A. The Receiver was appointed Receiver of ILP and IGP by Order of this Honourable Court granted in these proceedings January 19, 2021;
- B. The Receiver was appointed Receiver of IFC and ISA by Order of this Honourable Court granted in these proceedings February 1, 2021;
- C. Prior to the appointment of the Receiver, IFC had entered into separate agreements (the "Dealer Agreements") with Pulse, Capitol and Turnip pursuant to which IFC purchased from Pulse, Capitol and Turnip respectively certain rights as provided for in the Dealer Agreements in accounts and contracts for security products and services, which accounts and contracts were held respectively by Pulse, Capitol and Turnip, including, but not limited to, the right to collect the recurring monthly revenue with respect to the accounts (the "RMR Respecting the Accounts");
- D. The Dealer Agreements further provided, *inter alia*, that IFC had the right to pursue Pulse, Capitol and Turnip respectively for compensation and recovery of amounts paid by IFC to the respective Dealer as all provided for in the Dealer Agreement;
- E. By agreements dated June 10, 2020, the shares of IFC were sold to Intelife (the "IFC Share Transfer");
- F. As part of the IFC Share Transfer, a portion of the IFC accounts acquired from Pulse, Capitol and Turnip pursuant to the respective Dealer Agreements with each of the Dealers were assigned to Bojan (the "Bojan IFC Dealer Contracts");
- G. Notwithstanding the assignment of the Bojan IFC Dealer Contracts to Bojan, the administration of the Bojan IFC Dealer Contracts remained with IFC;
- H. After the granting of the Receivership Orders referenced above, the Receiver entered into agreements with respectively, Pulse, Capitol and Turnip providing for the administration of the accounts acquired by Intelife, including IFC, from, respectively, Pulse, Capitol and Turnip, which included administration of the Bojan IFC Dealer Contracts (the "Receiver Dealer Agreements");
- The Receiver Dealer Agreements provided that Pulse, Capitol and Turnip would collect the RMR Respecting the Accounts which they were administering pursuant to the Receiver Dealer Agreements and account for and remit the RMR Respecting the Accounts to the Receiver and provide an accounting with respect thereto (the "Dealers' Remittance and Accounting Obligation to the Receiver");
- J. After the granting of the Receivership Orders referenced above, Pulse, Capitol and Turnip objected to the assignment of the Bojan IFC Dealer Contracts relating to them to Bojan, alleging that the Dealer Agreements required their consent to such assignment (the "Objections");
- K. Turnip has withdrawn its Objection;

L. Pulse and Capitol have each entered into an Assignment and Amending Agreement with Bojan pursuant to which the parties have agreed to amend the terms of the Dealer Agreements and withdraw the Objections (the "Assignment Agreements");

AND UPON hearing counsel for the Receiver, counsel for Bojan and counsel for Pulse, Capitol and Turnip;

IT IS HEREBY ORDERED AND ADJUDGED THAT:

SERVICE

1. Service of notice of an Application to obtain this Order is hereby dispensed with.

GENERAL

2. Any capitalized terms used in this Order that are not defined in this Order shall have the meaning ascribed to them in previous Orders granted by this Honourable Court.

BOJAN IFC DEALER CONTRACTS

- 3. It is hereby declared that the assignment by IFC to Bojan of the Bojan IFC Dealer Contracts pursuant to the IFC Share Transfer is valid and effective and the Bojan IFC Dealer Contracts have been assigned and transferred to Bojan effective as of the date of the IFC Share Transfer.
- 4. Any requirement for the consent by the Dealers to the assignment of the Bojan IFC Dealer Contracts to Bojan pursuant to the Dealer Agreements or otherwise is hereby waived and dispensed with.
- 5. It is further declared that Bojan is entitled to:
 - (a) receive the RMR Respecting the Accounts and related to the Bojan IFC Dealer Contracts from and after the date of the IFC Share Transfer;
 - (b) any rights of IFC pursuant to the Dealer Agreements related to the Bojan IFC Dealer Contracts;
 - (c) the right to receive from the Dealers, or any one or more of them, any RMR Respecting the Accounts which has not been paid by the respective Dealer to the Receiver pursuant to the Receiver Dealer Agreements and the right to obtain from the Dealer an accounting of all RMR Respecting the Accounts collected by the respective Dealer pursuant to their respective Receiver Dealer Agreement.
- 6. The Dealers shall provide to the Receiver and to Bojan an accounting with respect to the Bojan IFC Dealer Contracts administered by the Dealer pursuant to that Dealer's Receiver Dealer Agreement and for the period that the Receiver Dealer Agreement was in effect, which accounting shall include:

- (a) amounts collected on each account;
- (b) amounts remitted to the Receiver on each account;
- (c) amounts outstanding on each account and uncollected by the Dealer;

(the "Dealers' Accounting").

- 7. The Dealers' Accounting shall be supplied to the Receiver and Bojan within fifteen (15) days of service of this Order.
- 8. The Receiver is not required to, and is released from any obligation to, pursue the Dealers, or any one of them, or any other party whatsoever, for collection or accounting of any RMR Respecting the Accounts to be paid or provided pursuant to the Receiver Dealer Agreements with respect to the respective Dealer.
- 9. The Receiver shall pay to Bojan, within thirty (30) days of the transfer of the Bojan IFC Dealer Contracts as provided for in this Order, all of the RMR Respecting the Accounts which the Receiver received or collected with respect to the Bojan IFC Dealer Contracts (including but not limited to amounts received by the Receiver from the Dealers, or any one of them, pursuant to any of the Receiver Dealer Agreements), less the monitoring and interactive fees with respect to the said accounts as set forth in Schedule "A" attached to this Order.
- 10. Bojan shall, within fifteen (15) days of the date of this Order, provide the Receiver information and directions for the transfer of the Bojan IFC Dealer Contracts to Bojan or his nominee or nominees.
- 11. The Receiver shall prepare and provide to counsel for Bojan an accounting of the RMR received on account of the Bojan IFC Dealer Contracts from the date of the Receivership until the date upon which all Bojan IFC Dealer Contracts are transferred to Bojan pursuant to the terms of this Order.

MISCELLANEOUS MATTERS

- 12. Service of this Order shall be deemed good and sufficient by:
 - a. Serving the same on:
 - i. the persons listed on the service list created in these proceedings;
 - ii. any other person served with notice of the application for this Order;
 - iii. any other parties attending or represented at the application for this Order; and

and service on any other person is hereby dispensed with.
