

**QWEST DIVERSIFIED CAPITAL CORPORATION (25-94586) AND
QWEST DIVERSIFIED ENERGY CORPORATION (25-094585) - IN RECEIVERSHIP
SECOND INTERIM REPORT OF RECEIVER**
Subsection 246(2) of the *Bankruptcy and Insolvency Act*

BACKGROUND

Effective November 3, 2015, MNP Ltd. was appointed as Receiver and Manager (the "Receiver") of the assets, undertakings and properties of Qwest Diversified Capital Corporation and Qwest Diversified Energy Corp. ("Qwest" or the "Company") pursuant to an order (the "Receivership Order") granted by the Court of Queen's Bench of Alberta (the "Court").

Qwest is a Canadian based junior oil and gas exploration and production company and has developed a number of oil & gas wells in Alberta.

ASSETS

The Receiver took possession and control of the Company's assets on November 4, 2015.

In February 2016, the Receiver entered into a purchase and sale agreement in respect of the oil and gas property owned by the Company, but the sale was not completed.

Effective September 14, 2016, the Receiver disclaimed all the leases of the Company to the Alberta Energy Regulator.

The Receiver's Interim Statement of Receipts and Disbursements for the period November 3, 2015 to June 30, 2017 is attached as Appendix A.

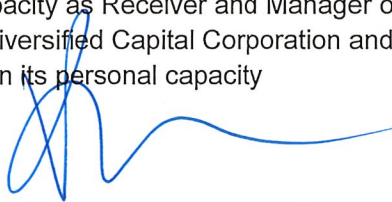
PLAN OF ACTION
