#### Remedy claimed or sought:

1. An Order directing that \$281,711.11, and all accrued interest thereon, which was paid into Court on October 4, 2018 pursuant to the Order of Master Hanebury granted on July 3, 2018, be released and paid to MNP Ltd. (MNP) as Receiver over the Debtors' (as defined in paragraph 13 below) Property identified in Schedule "B" to the Receivership Order (as defined in paragraph 14 below).

2. An Order for costs, if this application is contested.

### Grounds for making this application:

3. In 2014, Siu Kon "Bonnie" Soo (Soo) and Siu Mui "Debbie" Wong (Wong) were involved in an investment scheme to develop and market certain lands in Alberta. Soo and Wong acquired lands in Rockyview, Alberta legally described as:

> **MERIDIAN 4 RANGE 27 TOWNSHIP 23 SECTION 32 QUARTER SW** CONTAINING 64.7 HECTARES( 160 ACRES) MORE OR LESS **EXCEPTING THEREOUT:** HECTARES (ACRES) MORE OR LESS A) PLAN 9211808 DESCRIPTIVE 2.64 (6.52) **EXCEPTING THEREOUT ALL MINES AND MINERALS**

# (the Rockyview #2 Property)

- 4. The Rockyview #2 Property was held in trust by Soo and Wong's company, 1305402 Alberta Inc. (130), for various investors.
- 5. On September 25, 2014, investors in the Rockyview #2 Joint Venture brought a claim against Soo, Wong, and 130 in Alberta Court of Queen's Bench Action No. 1401-10536. On January 10, 2018, that action was dismissed for long delay.
- б. There are two other proceedings involving the various investors, which are styled as follows:

- (a) The within Action: 1305402 Alberta Inc. v. 0774238 B. C. Ltd.; Alberta Court of Queen's Bench Action No. 1801-07295 (Calgary Registry); and
- (b) DYMI Investments Ltd. v. 1305402 Alberta Inc.; B.C.S.C. Action No. S-147122 (Vancouver Registry).
- 7. The Rockyview #2 Property was subsequently sold (the Sale Proceeds). On November 24, 2014, Master A. R. Robertson ordered the Sale Proceeds be held in trust by Machida James McCall, counsel for 1305402 Alberta Inc, in Action No. 1401-10536 (MJM).
- 8. On various dates from February 2015 to August 2015, the British Columbia Securities Commission (the **Commission**) held a 25 day hearing in relation to alleged contraventions of the British Columbia *Securities Act* RSBC 1996, c. 418 (the **BC** *Securities Act*) by Wong, Soo, and others (the **Liability Hearing**).
- 9. On June 16, 2016, the Commission released its decision (the **Liability Findings**) arising from the Liability Hearing. The Commission found, among other things, that: (1) Wong and Soo illegally distributed securities, contrary to section 61 of the BC Securities Act; and (2) Ms. Wong and Ms. Soo had committed fraud.
- On November 28, 2016, the Commission held a hearing to determine the sanctions to be imposed on Wong and Soo (the Sanctions Hearing). On February 20, 2017, the Commission released its decision arising from the Sanctions Hearing (the Sanctions Decision). The Sanctions Decision imposed, among other things, an administrative penalty of \$6 million against both Wong and Soo. The Sanctions Decision was filed in the Supreme Court of British Columbia on March 3, 2017. On September 14, 2018, the judgment against Wong and Soo arising from the Sanctions Decision was registered in Alberta pursuant to an Order of Master A. R. Robertson.
- 11. On December 6, 2017, the Commission issued a Demand on Third Party under section 162.1 of the BC Securities Act to Brad J. Findlater of MJM demanding that MJM pay to the Commission the Sale Proceeds held in trust by MJM.
- 12. On July 3, 2018, 130 applied for and was granted an order directing payment of the Sale Proceeds from the Property into court. The Sale Proceeds were paid into court on October 4, 2018.
- On October 3, 2019, the Commission sought an order in BC Court File No. S-198522 (the **Receivership Petition**) appointing a receiver over certain property of respondents Wong, Soo, Wheatland Industrial Park Inc., D&E Arctic Investments Inc., and 1300302 Alberta Inc (the **Debtors**).

- 14. The Receivership Petition was granted on October 3, 2019 (the Receivership Order).

  Pursuant to section 152 of the BC Securities Act, MNP was appointed Receiver, without security, of the Debtors' interests identified at Schedule "B" to the Receivership Order.
- 15. The Sale Proceeds derived from the Rockyview #2 Property are listed at Schedule "B" to the Receivership Order.
- 16. The Receivership Order empowers the Receiver, MNP, to, among other things, take possession of and exercise control over the Property and any and all receipts and disbursements arising out of or from the Property.
