ORDER

THIS MOTION, brought by the former real estate agents of TheRedPin.com Realty Inc. ("TRP Realty") for a motion for direction on appeal, heard Monday, February 11, 2019 at the Court House, Osgoode Hall, 130 Queen Street West, Toronto, Ontario, M5H 2N5.

ON READING the factum, book of authorities and motion record of the former real estate agents of TRP Realty, and the joint factum, joint book of authorities and responding motion record of FirePower Debt GP Inc., as Agent and Trilogy Growth Fund, L.P., and on hearing the submissions of the lawyers for the parties:

1. THIS COURT ORDERS that the Appellants, the former real estate agents of TheRedPin, Inc. and TheRedPin.com Realty Inc. (the "TRP Agents"), shall be granted an extension of time to file their Notice of Appeal, *nunc pro tunc*.

2. THIS COURT DECLARES that the TRP agents have an appeal as of right pursuant to section 193 (c) of the *Bankruptcy and Insolvency Act*, R.S.C., 1985, c. B-3, and do not require leave to appeal.

3. THIS COURT ORDERS that the Applicant/Respondent Firepower Debt GP Inc., as Agent and the Respondent Trilogy Growth Fund, L.P. shall pay the TRP Agents' costs of this motion in the amount of \$2,000.00, inclusive of disbursements and HST, within thirty (30) days of this Order.

4. THIS ORDER BEARS INTEREST at the rate of 3% per year commencing on February 11, 2019.
