FORM 87 NOTICE AND STATEMENT OF RECEIVER SEC. 245 (1) AND SEC. 246(1) OF THE ACT

The Receiver gives notice and declares that:

 On September 18, 2020, on the application of Pillar Capital Corp., MNP Ltd. ("MNP") was appointed receiver and manager (the "Receiver") of Turuss (Canada) Industry Co., Ltd ("Turuss") by Order ("Receivership Order") of the Ontario Superior Court of Justice (the "Court").

Description of the land and building (the "**Real Property**") of Turuss located at 60 Queen Street North, municipally known as 60 Industrial Park Road, Chesley, ON comprise:

- a) 340,000 square foot, multi-tenant industrial facility
- b) 33.76 acres of property

In addition to the Real Property, the assets of Turuss include certain equipment including 5 Yale forklifts and certain wood-floor manufacturing equipment (together with the Real Property, the "**Property**"). No books and records of the Turuss are available and as such the Receiver has been unable to ascertain the book value of such assets.

- 2. The Receiver took possession and control of the Property described above on the 18th day of September 2020.
- 3. The following information relates to the receivership:
 - a) Address of the insolvent Debtor:
 - 60 Industrial Park Road, Chesley, Ontario, N0G 1L0
 - b) Principal line of businesses:
 - Turuss historically manufactured, imported and distributed hardwood flooring. As at the date of the Receivership the flooring business is dormant and Turuss is effectively a real-estate holding company whose sole purpose is to own and manage the Real Property.
 - c) Location of the business:
 - 60 Industrial Park Road, Chesley, Ontario, N0G 1L0
 - d) Amount owed by insolvent person to each creditor who holds a security on the property described above:
